The "Organization of Islamic Conference (OIC) Member States' Stock Exchanges Forum Meeting" (Forum) was initiated with a decision taken in line with the request made by the Twentieth Session of the Standing Committee for Economic and Commercial Cooperation of the Organization of the Islamic Conference (COMCEC) for launching a framework of cooperation among the OIC stock exchanges. The first Forum meeting was held on March 28-29th, 2005 in Istanbul by the Istanbul Stock Exchange (ISE), as mandated in the 20th meeting in November 2004 of the COMCEC, to enhance cooperation among the stock exchanges of the respective countries.

The first Round-Table meeting on the promotion of cooperation among the OIC Member States' Stock Exchanges, organised with this motivation was attended by the representatives of 11 OIC stock exchange^[1] and the related 7 OIC institutions^[2]. The "OIC Member States' Stock Exchanges Forum" was named at this first Round-Table meeting.

Istanbul Stock Exchange hosted the second Forum Meeting of the "Organization of Islamic Conference (OIC) Member States' Stock Exchanges" in Istanbul on October 18-19, 2008 with the attendance of the representatives of 17 stock exchanges^[3] and 7 Central Depositories, Clearing and Registry Institutions of the OIC Member States^[4] and 11 other organizations^[5].

As a significant step in the progress of strengthening cooperation among the OIC stock exchanges, the formation of the "Organization of Islamic Conference (OIC) Member States' Stock Exchanges Forum" is an important milestone.
